The circulated agenda was revised as there were concerns about the meeting being quorate with existing members.

- 1. **Nominations for new members:** As Dennistoun Community Council has 17 places and there were only 16 nominations, all nominated persons were elected to the community council.

- 3. Area Partnership Representative: Ruth Johnston was elected and Jenifer McGlone elected deputy.
- 4. **Approval of 2013 A.G.M. Minutes:** Only two full members who attended the 2013 A.G.M. were present, and Frank Plowright had produced the minutes. After consultation Lee Handlin deemed it adequate that the A.G.M. minutes had been passed by a quorate meeting in November 2013.
- 5. **Chairman's Report.** Stephen precised his written report, which is appended to the minutes. One item occurring since the report was written was the commendation from Napier University's Centre for Social Information, singling out DCC as an example of effective online communication. Glasgow Council tweeted this information to their 55,000 followers and there will also be a piece in the Evening Times.
- 6. **Treasurer's Report:** The finances for the previous year to September 30th have still to be independently examined, and the Treasurer was absent. She provided an audit showing an opening account balance of £1799.44 and closing balance of £1552.05. The last bank statement shows a balance of £2902.85, but that includes £1000 reserved for the Map and Ap project, and £375 reserved for as yet unpresented invoices, and doesn't include £25 banked since. We have a holding of £27.36 in petty cash.
- 7. **Indpendent Examiner of Accounts for 2014-15**: To be appointed.
- 8. **Appointment of Associate Members**: Market Gallery, Claire McKechnie, Milnbank Housing Association and Reidvale Housing Association were re-appointed associate members of the community council. Dennistoun Diggers will be contacted regarding their previous associate membership.
- 9. **Additional holdings and resources:** We currently have two gazebos, 2 portable tables and 10 deck chairs available for community use as per the terms of purchase.
