### 1. Appointment of Minutes Secretary

Paul Lafferty put himself forward and was duly approved

#### 2. Appointment of Vice-Chair

John Bones was proposed by Stephen Birrell and seconded by Sean Kelly. As there were no further nominations, John Bones was elected unopposed.

#### 3. Introductions of new/existing Members

Everyone introduced themselves and said a few words about themselves.

### 4. Elected Members Update

**Councilor Casey** 

- Bin operative leaving close doors open. Cllr Casey has made LES aware of issue. LES guidance to operatives is that close doors should be shut. Seems to be still happening. Cllr Casey is happy to speak to LES again particularly if there are specific closes affected regularly.
- Bin replacement. There is no intention, at the moment, for tenants to wheel their own bins to the front of the close on collection day.
- Street Lights at Cumbernauld Road and Meadowpark Street have been fixed. Armadale Street speed bump to be finished soon, Hillfoot Street painted no entry sign to be sorted.
- Next Bike scheme to be extended to Alexandra Parade and Duke Street stations. Citypark may be an option for the future.
- Councilor has booked his surgeries starting September.

#### 5. Previous Minutes

Subject to some minor changes, the minutes were proposed by Russell and seconded by Lauren B. Minutes were subsequently approved.

#### 6. Matters Arising

a) Golfhill School.

Frank proposed DCC object to the Planning Application on the following grounds:

- 7 storey building will dwarf surrounding buildings
- Parking is inadequate and process was flawed
- School building should be retained in whole

Cllr Casey declared an interest and didn't take part in the discussion.

After some discussion and clarifications around the height of the proposed buildings, it was agreed to drop the first objection.

Brian raised the point that the application states there will be no trees felled as part of the development. That doesn't appear likely so this was added as a further ground for objection.

Also, the Parking element is still up for discussion though the deadline for that is 19<sup>th</sup> July.

After further discussion, the following proposed objections were put to a vote:

- Management of Parking
- Access to the site
- Tree-felling
- Retention of the whole school building

The vote was 3 in favour, 8 against with 2 abstentions.

The proposed objections were amended to:

- Management of Parking
- Access to the site
- Tree-felling

This was agreed by a vote of 11 for, one against with one abstention.

Action: Chair will draft a letter of objection with the support of Brian.

Brian pointed out that it takes at least 6 objections to make a difference so if people have concerns, they should consider an individual objection.

There was further discussion about the current security of the site.

Action: Cllr Casey will raise concerns with the site owners.

b) War Memorial.

Lauren B informed the meeting that the Chair of the War Memorial Group will keep DCC informed of developments.

#### 8. Chair's Report

- a) Attended Springburn C.C. to discuss possible cross-over issues; parking is a possibility. Springburn also take up some issues on behalf of Royston residents if approached. They also have their own dedicated Police Officer in attendance.
- b) Met with Reidvale Board member to establish communication
- c) Attended Market Gallery event and is meeting Director next week
- d) Community Council Discussion Forum. No agenda was sent out in advance for this. There were no attendees from DCC
- e) Calton C.C. has disbanded but Lawrence O'Neill is confident a new C.C will be in place by September
- f) Freedom Café. This is a new initiative funded by Scottish Government as part of its approach to tackling Food Poverty. It is run from the Everlasting Arms Church. It receives food support from local outlets including KFC and Tesco. It has a "pay what you can" community cafe on Fridays and a fully functioning training kitchen for cooking courses. They are looking to make contact with Dennistoun Diggers re. growing your own food. Nick McCurdy is the contact person.
- g) Met with local police. Main points from the discussion are:
- London Road no longer has response officers; these will come from Shettleston
- New operational teams work on intelligence received and are focused on housebreaking and youth disorder. They have good detection rates but need public to report concerns.
- Police have Glasgow East twitter feed which is a good way of keeping up to date
- Milnbank Community Café has 2 police in attendance on Thursdays
- It is important that people use the appropriate service e.g. contacting Community Safety rather than the police
- Police will attend D.C.C. meetings but will only give a narrative report. They will communicate through the Secretary so follow up on Action Points will be through Stephen

### 9. Sub-Committee Reports

a) Parking

Lauren B spoke to the circulated Report. The report was noted and sub-committee will continue working on the actions. Cllr Casey is happy to receive emailed complaints from residents re. parking.

b) Environmental

Sean spoke to the circulated Report. The report was noted and the sub-committee will complete their audit which will form the basis of an Action Plan. Cllr Casey is happy to take up issues and get LES involved.

c) Communications

Wesley spoke to the circulated Report. The report was noted and the sub-committee will continue working of the actions.

d) Day out in Dennistoun

Lauren B urged people to pick up maps and distribute them.

#### 10. DAP Report/FoGN Report

Ruth spoke to the circulated DAP Report. Main issue is the amount of Area Budget left; about half has already been committed. Cllr Casey pointed out that DAP has yet to set its priorities for the Area Budget and this will impact on how the money is spent going forward.
