East End Regeneration Route

GCC agreed by a vote on 28/10/21 that: "Phase 3 of the East End Regeneration Route is incompatible with the Council's planned action on Climate and Ecological Emergencies; incompatible with forthcoming transport strategies; and does not align with public need; delivery of Phase 3 of the East End Regeneration Route will no longer be pursued; and conversion of the former Riddrie/Haghill railway line bed to a new active travel route should be explored as part of development of Active Travel plans and Liveable Neighbourhood engagement work."

Fly Tipping Pilot Scheme email received from GCC, dated 27 October 2021

We are planning to target some streets in Dennistoun and Calton as part of a Fly Tipping initiative pilot week beginning 22nd November 2021 that have been flagged up via complaints and reports from analytical data, this is being run as a pilot scheme and will involve the following:

- Letters sent to all residents in those streets detailing the correct procedure for booking a Bulky waste uplift and that people can be fined for Fly Tipping.
- Posters put up on relevant streets.
- On 22nd November officers from my section (Neighbourhood Liaison Coordinators) will carry out ENVA
 audits on all the targeted streets to record/report for repair/removal all litter, weeds, dog fouling,
 vandalism, potholes and graffiti, where Fly tipping is evident this will be highlighted with Yellow 'Scene of
 crime' tape, Community Engagement Officers will attend to knock on doors, check CCTV etc to try and
 ascertain culprits and hand out fines if successful before notifying cleansing services to remove the Fly
 Tipping.
- Commercial Services Enforcement will engage will all local businesses to assess if they have a Commercial waste contract in place, failure to have proof could lead to a fine being levied.
- The above action will last for the full week.
- 4 weeks later the same streets will be checked again to measure impact.
