- Glasgow Airport flight path amendments: Glasgow airport proposals didn't meet the Civil Aviation Authority's requirements and will have to be resubmitted. FP research indicates that revised flight paths would be high enough over Dennistoun that there shouldn't be much noise.
- Meat Market Regeneration Action Plan: WW attended consultation session. Hosted by PAS (Planning Aid for Scotland) with/on behalf of Milnbank HA. Project heading of 'Sustaining Choices' [Link]. Funding from Paths For All's 'Smarter Choices Smarter Places' (SCSP) scheme [Link]. Area covered is Dennistoun, Haghill, Calton, Bridgeton, Carntyne, Riddrie, Dalmarnock and Parkhead. About a dozen attendees, including Bluevale Community Club rep, Living Rent rep, and a handful of residents (incl. Dennistoun Information Page admin). Largely positive discussion, structured around the Place Standard themes, covering local amenity provision, quality of spaces, and transport options. Support for keeping Whitehill Pool is a priority. At the meat market sheds, there was a stated intention to promote active play options for kids. Support for a suggestion on training people with e-bike maintenance skills, to provide a service for a growing demand not widely available. Future plans: July/August sessions to increase involvement; August/September Analysis of results and creation of a draft Active Travel Action Plan identifying short, medium and long term actions. Initial conversations with delivery partners; September/October Further feedback event to review draft Action Plan.

#### UPDATE FROM CHARLIE KEANE, GCC NEIGHBOURHOOD LIAISON CO-ORDINATOR FOR WARD 22 DENNISTOUN

**BT Kiosks**, BT inform me a survey/audit was carried out April/May this year to revisit where they have kiosks and the need for them etc, my last update was they are being audited by Ofcom and until complete no decisions or movement can be made on assets/kiosks etc, I will keep onto them and see where we end up.

**Royal Mail Grey Parcel Cabinets**, all in the ward have now been reported/requested to be removed (all seem to be obsolete) Royal Mail have agreed to this and passed them onto their contractors, at this time the cannot give a timetable for the removal schedule, a few that are still in use will also be painted Red (To make them look fresher and high light to visually impaired etc.

**Ad-trailers/caravan's**, so far we have had 3 removed (Duke St/Wellpark, Duke St/John Wheatley college, Edinburgh Rd/Todd St/Ledaig section), we have others dotted about which I am pursuing (Those attached to vehicles which are fully taxed etc at this point cannot be touched which is frustrating)

**Graffiti**, I have tried to be vigorous in this campaign to 'wipe' it out by reporting to the furniture owners (BT, SPN, Vodaphone, EE, Amey, Scottish Water, Outdoor, Global and many others, not to mention quite a lot to GCC), I report all of the GCC graffiti via My Glasgow as well as Fly Posting, all other graffiti goes directly to the owners, I have put together a 2 page reporting procedures paper to assist myself, RSLs and other colleagues, if you feel it would be of benefit to DCC to have a copy please just ask.

Are you aware that all GCC Street Litter Bins within Ward 22 now have QR codes to make them much easier to report as full or vandalised etc? As long as your phone has a QR scanner (free downloads online) just point it at the code and it will direct you to the GCC website to report, My Glasgow App is currently being updated too.

**Golfhill Primary & wider campus**, a combined PTA are having dialogue with GCC regarding traffic issues surrounding the schools, this site with Roads and is ongoing.

**Hedges**, quite a few overgrown hedges have now been inspected and the owners lettered to take action, in some cases GCC have carried out the works and billed the owners, in a few other cases RSLs & Land Lords have helped out too (With a little gentle persuasion)

**Fly tipping/litter**, over the last few weeks Community Enforcement Officers, Commercial Enforcement and Dog Wardens have carried uniform/non uniform visits along Duke Street, Alexandra Parade and the streets in between, this has led to 3 Fix Penalty Notices for Fly Tipping/littering and visits to speak to various commercial outlets to advise that they must have a commercial waste contract in place.

There are another few fly tipping sites, notably one on Marne Street which is currently with Public Health to ascertain any evidence that may be gleamed, then will be cleaned/removed.

Looks like the builders have completed their works at Marne Street, so hopefully this will calm down & become much quieter (parking/traffic) and cleaner.

**Birkenshaw Street**, Public Health are trying to ascertain and engage with the owners of the vacant land at this location in an effort to have measures put in place to stop the fly tipping, within the next 2 weeks NRS are looking to clear this site (again) and continue to monitor.

#### TIMELINE AND BRIEFING TO DCC FROM WHITEHILL POOL WORKING GROUP

Nov 2018 – GCC announced to plan to close a number of venues operating by Glasgow Life across the city including Whitehill Pool, Golf Course and Haghill Gym

Meeting arranged by DCC in December 2018 at Dennistoun Library to address the closures

Alan Casey revealed that Whitehill had a backlog of £4.5m worth of essential maintenance

February 2019 – GCC/GL announced the venues will remain open – but require investment - £4.5m to remain open

April 2019 – Alan Grant (local born architect) produced a Survey Report on behalf of the campaign group. He estimated around £4m as the cost of repairs / upgrade

Jan 2020 – A budget was set aside to carry out to investigate and repair the drainage damage to the Learners pool at Whitehill

March 2020 - Covid

October 2020 - GL conducted a detail survey of the building

3 costed options –

1. £4m of repairs to keep building running – until a major repair was required Really just kicknig th ecan down the road – buying time

Not value for money

2. £17m Major Refurb – with 2 year closure

Value for money

3. £25m for a new pool to be built

April 2022 - Meeting with GL to agree way forward - Prepare a Business Case

At present working on gathering information to support the business case

#### **Meeting Notes**

We need to activate the campaign again to ensure we get full attention of GL/GCC in the preparation of the Business Case. Need to agitate.

Restricted opening hours continue to cause major problem to clubs limited access to pools. Temple Club has experienced major restriction both in pool use and parking problems at Tollcross. Glasgow Life continues to hide behind staff shortage causing the restrictions.

Let GL/GCC know that the Campaign will be actively engaging with the local community to obtain information with regard to Physical and Mental Well-being needs of the area

#### Request sight of the Business Plan developed so far - including technical details and costs

Also necessary remind the local community that the threat of closure is still very real.

# **Detailed Summary of Users**

Clubs restricted hours and waiting lists; Whitehill users and Classes; Schools; GL swim teaching classes

The numbers through the door, numbers projected build up pre-covid?

The site is designated for use for recreation purposes only - by Lord Dennistoun (now Trust).

### **Social Needs of Area**

It is recognised nationally that large numbers of young people have no swimming skills or access to swim teaching.

There is no mandatory requirement for swimming lessons to be part of the current, Scottish School curriculum, and it is thought this is why the number of children leaving primary school unable to swim is one of the reasons for the increase in non-swimmers. **See Post Meeting Info below.** 

General lack of fitness and obesity issues are major problems across the city

**Draw up a list** of Organisations, Charities, Groups and Individuals who deliver a service to address local social needs.

Need to "knock on doors" and obtain details of what they do and how much.

BBC News:- Scotland has the highest rate of accidental drowning of all the UK nations - despite a strategy to cut water deaths in half, figures show.

The plan to halve accidental drownings by 2026 <u>was announced four years ago</u>, but deaths last year rose to their highest level since 2015.

The Scottish government published a water safety action plan in March.

A spokesman said the plan was designed to support the 2018 drowning prevention strategy and included extra funding, updated signs and lesson plans for pupils.

March 2020 GL had 70 Swim Teachers delivering 1000 classes per week

June 2022 GL has less than 35 Swim Teachers delivering 350 classes per week. Currently only 5 of the 12 pools in the city (Tollcross; Maryhill; Gorbals; Scotstoun; Springburn) provide swimming lessons.

1000 previous customers have requested places in swim classes when programme is able to expand.
