### <u>Whitehill Pool</u>

#### 8 Elected Member Updates

Poor attendance by Cllrs at CC meetings in general was discussed. <u>Cllr Carroll</u>

Reopening of Wellpark Hall is a work in progress. A walk around to identify maintenance issues has been arranged. Rent increases ahead of rent freeze (backdated to 6th September) is a concern. New Short Term Let licensing requirements start on 01 Oct 2022. Planning Permission not yet a part of this (GCC would need to apply to Scot Gov for these powers by defining a 'Short Term Let Zone'). Duke Street Avenue (High Street to Bellgrove Street) funding has been confirmed. Concerns heard about various overlapping layers of consultation and strategy and the lack of communication. No further info heard from mooted community garden group(s) after contact being made.

## UPDATE FROM ANNE MCLAUGHLIN MP – 11TH OCTOBER 2022

It's been a busy month since my last update; with Liz Truss and her shambolic government handing out a tax cut to the richest in our society at the expense of everyone else and tanking the pound. This has caused untold damage to the economy at a time when so many are already incredibly worried about this winter and at a time when parliament was in recess so they could not be held accountable by MPs. They may have u-turned on this despicable policy now but the damage has already been done.

#### Local Visits

Closer to home, I have had the opportunity to visit some local organisations in Dennistoun and beyond.

I had the wonderful opportunity to go along to a local retirement housing complex to speak to residents about my work as an MP and how my office can help them. As always I'm glad I got to speak to people as my office has been able to help with things people would not have come to me with otherwise.

I have also been along to several community events across the constituency and have held meetings with charities and organisations about the Cost of Living Crisis.

#### Helping people in Glasgow North East

As always, my office and I have been incredibly busy helping people out with an array of issues including:

- Helping a constituent with an enrolment issue at University, meaning they were able to start their studies as planned.
- Contacting a Housing Association about a dangerous repair issue that had been reported but not resolved. The constituent will be able to feel safe in their own home again as the Housing Association have agreed to complete the repairs as a matter of urgency.
- Speaking to Scottish Water about damages to someone's property and getting them information on how to claim compensation.
- Getting tax credits that were due to a constituent backdated by HMRC plus £150 in compensation as an apology from HMRC.
- Helping a constituent who had applied for the 'Homes for Ukraine' Scheme get a positive decision.

This is just the tip of the iceberg when it comes to things my office can and do help people with. If you have anything you think I could help you with – or even if you don't think I could help but don't know who to ask – please do get in touch

#### **HMRC Late fee letters**

A number of constituents had contacted me regarding a late fee bill received from HMRC. However, none of these constituents were self-employed. I'm so glad these constituents knew to come to me as we have been able to get all of these cases resolved, meaning they are no longer worried about huge bills they should never have received in the first place.

#### **Representing constituents in parliament**

As I have previously mentioned, in addition to my Spokesperson roles (Justice and Immigration), I am campaigning on 3 main issues at Westminster right now.

1) **Campaign to outlaw so called self-disconnection.** If I stop paying my heating bills, my supply company CAN cut me off but not for a long time. They MUST give me the opportunity to pay it up and they must go through

different processes. If someone with a prepayment meter goes 1 penny over the £10 emergency credit, they are cut off immediately. Those worst of in our society are the most likely to be on pre-payment meters and are left dangerously open to being left with no power unless they can feed the meter.

Since I raised this in my last report I have written to Jacob Rees-Mogg – the Business Secretary – to ask him to support my campaign to outlaw self-disconnection. I am yet to receive a response.

I have also taken a motion on this issue to SNP party conference and I'm glad to say that this passed and will now become party policy.

2) **Campaign to extend the deadline for pensioners to receive £650 Cost of Living payment.** Since my last report, I have continued to fight for pensioners eligible for pension credit, who have not yet applied to receive the £650 Cost of living payment if they apply before the end of the financial year. I had written to 2 previous chancellors and have now also written to the current chancellor, urging them to extend the deadline to 31 March.

I have since received confirmation from the DWP that those who are eligible, but have not yet applied, will qualify for the second half of the Cost of Living payment - a sum of £324 - if they apply before the 24<sup>th</sup> of December this year. While this is a step in the right direction, it is still not good enough and I will continue to fight for the deadline to be further extended and for those eligible to receive the full £650 payment.

3) As I have previously mentioned I'm very concerned about **small businesses, charities and third sector organisations** who were facing unimaginable increases on their energy bills. Since my last update the UK Government have reluctantly introduced a price cap for commercial energy rates, but the catch is it's only for 6 months. This leaves organisations and businesses struggling to plan for the coming year - 6 months is nowhere near long enough to make viable plans or commitments.

I have presented a petition in the House of Commons calling on the Government to extend this to the two years that domestic customers have been given and I will keep pushing them to do this.

#### Local Surgeries

My most recent surgery was held door-to-door in the Drygate area. It was great walking around the area and speaking to residents about the issues that affect them.

My next surgery in Dennistoun is on Saturday 19th November from 11am. Dennistounians can however, attend any of my surgeries and the list is here Surgeries (annemclaughlin.scot)
