## 1 AGM Planning

- Venue: St Andrews East Church Hall.
- VT and WW will not be standing for the roles of Chair, Secretary and Minute Secretary.
- FP is willing to stand for Vice-chair for another year, and would potentially take on the Minute Secretary role.
- LC is willing to stand for Treasurer for another year.
- The suggestion of co-chairs was raised, and met with some enthusiasm. The constitution formalises the naming of the roles, but there's nothing to stop a Chair and Vice-chair having an equal share of the workload.

#### 2 HMOs and Short-term Lets

- DCC has had a policy for a number of years that an objection is submitted in response to applications for new HMOs, with applications for renewals not being objection to unless there are applicable specific circumstances.
- It is understood that there are currently 21 in the DCC area.
- Generally it was felt that the HMOs in place are generally not a problem, whereas short-term lets have a more variable track-record.
- The various competing housing market pressures of, for example, students requiring residences vs families requiring residences was noted in terms of demand for a similar type of housing stock.
- Noted that a few HMOs have been sold and converted back to single private residences.
- Vote on the following motion: Keep the existing DCC policy of objecting to applications for new HMOs and extend it to include applications for Short-term lets (from when that application system becomes operational). Motion passed with eight votes in favour, and one abstention.

## 3 Treasure Hunt

- GCC grant condition requires the GCC logo be included on promotional material.
- No response to email (or follow up) to the Co-op community rep.
- Prize to be a voucher for art materials.
- Prizes to be distributed to schools for awarding (rather than holding a single prize-giving).
