APPENDIX A

Chair's Annual Report

Verbally supplied by Frank Plowright. Issues missed during verbal presentation added and highlighted.

DCC held nine ordinary and three planning meetings over the past year. We currently have ten active_Community Councillors. As in 2023, many issues dominating our agendas were frustratingly familiar.

Unresolved streetscape issues

We have continued to press for action on the many streetscape issues in the area, such as road markings and drainage. Long awaited inspection of drains took place during the summer, and DCC has been supplied with documentation noting which need follow up action. DCC has supplied a detailed presentation of suggestions about how to use an area improvement grant, yet these have been persistently ignored by the council, whose lack of transparency, delay and obfuscation is all too familiar.

Local Initiatives

DCC has promoted and engaged constructively on a wide range of initiatives such as the Neighbourhood Infrastructure Improvement Fund (NIIF), Liveable Neighbourhood (LN), Avenues Scheme and current fill in consultation. As in 2023, it's not been easy to get answers to specific queries about these various projects, including how they all join up together.

Prior to the summer Westminster election DCC hosted a hustings at which seven of the nine candidates seeking election answered questions, and it was attended by approximately 100 members of the public.

Reidvale HA

DCC continues to monitor events at Reidvale Housing Association where the proposed takeover was rejected by members.

Whitehill Pool

The future of Whitehill Pool continues to be a subject of concern. The problems in 2023 were compounded by the discovery of potentially dangerous concrete in November 2023, since when getting any information has been an exceptionally frustrating experience. Despite requests made by ourselves and councillors, there has been no progress since March when we were told City Life intends to solicit quotes for removal and repair work for their entire estate, with Whitehill Pool just one building. Bill Stark of the Save Whitehill Pool campaign regularly attends DCC meetings.

Dennistoun Area Partnership (DAP)

Community Councillor Ian Sheerer has attended DAP meetings, and the DAP has disbursed funds to a number of local projects and organisations. There has been no progress on distribution of NIIF funds. Despite being asked to do so in March, council officials have yet to supply costings asked for specific projects submitted by DCC.

Community engagement

We maintain a DCC webpage, update regularly on Facebook, highlighting consultations and areas of local interest, and continue to promote our meetings and encourage members of the public to attend.

Treasure Hunt

The DCC Treasure Hunt again took place in September for all children attending Dennistoun's primary schools. It was possible thanks to funding from Glasgow Council and sponsorship from Forbidden Planet. It was noted the take-up this year was disappointing, and FP will provide a full report to the November 2024 meeting.

Planning

Brian Johnston, our Planning Rep, continued to scrutinise and respond to planning applications, including objections to proposed changes to licensed premises, in line with local concerns. DCC continue historic objections to new House In Multiple Occupation (HMO) licence applications, and licence applications under the new Short-Term Let scheme, where these licences apply to a whole-property let. While not wishing to penalise residents who wish to provide short-term accommodation in a spare room, we believe the rise in short-term lets,—especially in tenement buildings with communal areas, weakens communities, fuels rent rises, and reduces availability of property for long-term rental. There were no other planning or licencing matters of concern.
