Uncontested Election

Should 5 or fewer valid nominations be received by the closing date, the uncontested election meeting will take place on Tuesday 14th April 2026 and will begin at 7pm in **St Andrews East Church Hall, 685 Alexandra Parade, G31 3LN.**

Contested Election

Should more valid nominations be submitted to Glasgow City Council by the above closing date than there are vacancies, a secret ballot will take place on a date to be determined.

3. All persons aged over 16 years and resident in the Community Council area are entitled to vote in elections.
4. All proposers and seconders must also be resident in the Community Council area and aged over 16 years.
5. Candidates, proposers and seconders names should appear on the Electoral Register (alternative measures for identification status of candidates may be undertaken in certain circumstances).

6. Successful candidates elected to serve on the Community Council, will do so until the next scheduled full election to be held in October 2026.
7. If you submit a Nomination Form, Glasgow City Council staff will contact you to confirm the validity of your nomination and will inform you at the close of nominations if a contested election is to take place.
